## **Alberta Grazing Lease Rental Rate Review**

In 2009, beef industry stakeholders worked together and submitted a proposal to government to update the grazing lease rates. This report was shelved and never acted upon.

In subsequent meetings with government members, the WSGA has requested this report be revisited. In the fall of 2014, a review of the grazing lease rental rates was held. In a series of meetings with industry stakeholders comprised of the WSGA, Alberta Grazing Leaseholders Association, Alberta Beef Producers and the Northern Alberta Grazing Leaseholders Association, ESRD was able to come up with an updated proposal that was submitted to government.

The basic components of the proposed new Royalty Rate are:

- Elimination of assignment fees across the province. These range from \$100/A in the south to \$5/A in the north. Government agreed it was nothing but a tax.

- Royalty based on a grasser model where the leaseholder buys a 650lb in the spring and sells an 850lb in the fall. The profit margin is calculated after deducting the agreed on costs as well as a 7% profit over and above the cost of production.
- The province would be divided into two zones, the dividing line being Highway 16. There was acknowledgement that there could potentially be some additional costs operating in the north, so a bit lower rent was justified.

For those of you interested, a presentation on the new royalty rate proposal is being offered as part of the AGLA AGM held prior to the WSGA AGM at the Sheraton Hotel and Conference Centre in Red Deer.

## **WSGA MEETS ESRD MINISTER AT LEGISLATURE**

Representatives from WSGA travelled to Edmonton on January 19 to meet with ESRD minister Kyle Fawcett. Although in some ways it seems like an exercise in futility with this being the fourth minister in as many years the WSGA has met with, each time starting over the same discussions, we hope we were able to drive some points home. We emphasized the need to address the problem legislation that is SARA at the upcoming Federal-Provincial-Territorial meetings, underlining that although we support the efforts to save species at risk, these efforts should not be solely at the cost of the land steward.

We also started the discussion on developing, or at the very least, removing the regulatory barriers to a marketplace for ecosystem goods and services. Other topics we talked about include wildlife issues and land use planning.

Whether anything comes of this meeting, we will have to see. The future of this current cabinet is yet uncertain and it's not inconceivable that we will have to start all over with a new ESRD minister in the months ahead.
